Eligibility:

If, based on the sole judgment of LIFS if the Parade of Nations Participant shall be deemed unsuitable in any respect the agreement will be cancelled and the Parade of Nations Participant will be asked to leave the premises immediately.

General:

- LIFS requires Parade of Nations Participant to be dressed and ready to participate 15 minutes prior to the scheduled Parade. The time and meeting area will be determined closer to the opening day of the Festival.
- All Parade of Nations Participant are asked to report upon arrival to the Main Stage.
- All matters and questions not covered by the Agreement herein are subject to the decision of LIFS.
- The Agreement may be amended at any time by LIFS and all amendments that may be so made shall be equally binding on all parties affected by them, as are the original Agreement
- Every effort will be made to accommodate special requests, but they cannot be guaranteed.

RELEASE OF LIABILITY, WAIVER OF CLAIMS & INDEMNITY AGREEMENT

TO HOLD HARMLESS AND INDEMNIFY Langley's International Festival Society and their representatives from any and all liability for any property damage or personal injury to any third party, resulting from my activities and my participation in the activities offered by or associated with Langley's International Festival Society.
