By signing the Agreement for the LIFS/DIMAR Tennis Tournament Participant, subsequently called 'Tennis Tournament', it is agreed that the aforementioned team/individual will adhere to all the terms as outlined within this document. Langley's International Festival Society (**LIFS**) requests the full cooperation of each Team/individual.

Eligibility:

LIFS/DIMAR reserves the right to determine the eligibility of a Team/individual for inclusion in the Festival. If, based on the sole judgment of **LIFS/DIMAR**, the Team/individual shall be deemed unsuitable in any respect the agreement will be cancelled and the Team/individual will be asked to leave the premises immediately.

ONLY ADULTS ARE PERMITTED TO PARTICIPATE

Costs: Each Team will pay \$25.00 + 3.00(HST) = **\$28.00 Tournament Fee** per person.

Cancellations:

- Any cancellation of participation as a Team/individual must be submitted in **writing** to Mariana Mueller. 'Cancellation' is not valid unless the cancelling party receives confirmation from LIFS/DIMAR that their request has been received.
- If cancellation is **on or before August 25, 2011** the Team/individual will incur an administrative fee of \$50 per space.
- If cancellation is received after **August 25, 2011** there will be **no** refund.
- Team/individual no-shows will be treated as cancellations. There will be no refunds for these cancellations.

TEAM LEADERS SHOULD ENSURE THAT EACH PARTICIPANT IS MADE AWARE OF THE RULES FOR PLAYER CONDUCT AS LISTED BELOW.

Rules: Each Team will play at least 3 Three Matches (2 winning sets out of 3) Men Doubles, Women Doubles and Mix Doubles. Balls will be provided. Teams will be contacted 24 hours before the beginning of the Tournament.

Pre-Tournament Procedures: Credential Checks

Before team plays its first game, Tournament Officials will conduct credential checks and verify that each team has submitted a complete registration form with payment. All teams must submit the following:

- Full team roster
- Identification (driver's license) for all players
- Completed Waiver signed and dated by all players

To ensure that this Pre-Tournament Procedure is successful, each team manager/representative must be present a minimum of 1 hour before their first game and have all paperwork submitted a minimum of 30 minutes prior to their opening game time to the Tournament Official.

Field of Play:

The Field of Play has been modified to adjust for the 'mini' tournament format.

Number of Players:

A Team shall consist of 4 players Ladies and Gentlemen. Any team that fails to field the minimum number of players shall forfeit the game to the opposing team.

Post-Game Procedures:

- As a courtesy, both teams meet at centre field and congratulate each other for a game well played.
- Referees will submit completed game reports to the Tournament Officials
- Team Managers/Representatives of each team will have the opportunity to confirm the score with the site director after each game. One hour after the completion of the game, any score that has been submitted by officials and is **NOT** challenged by team managers/representatives is considered as **FINAL**.
- Due to tight time constraints once your game is finished you will be required to clean up your bench area of any garbage, water bottles, equipment bags etc and leave the area. This will enable the next team to set up and prepare for their game.

In consideration of Langley’s International Festival/DIMAR Tennis Tournament permitting me to participate in its activities / sports, the use of their equipment and the use of their facilities, I hereby agree as follows:

1. **TO WAIVE ANY AND ALL CLAIMS** that I have or may have against **LIFS/DIMAR** Tennis Tournament and their representatives.

4. I further state that I am in proper physical condition to participate in this event/activity and am aware participation could, under certain circumstances, result in physical injury.
