TERMS:

1. We require that you or your group arrive, dressed and ready to perform **30 minutes** prior to the scheduled time on stage. All performers, or their spokesperson is asked to report upon arrival to the Registration Desk (Coordinator of Performing Arts). Dressing rooms will be provided for change of costume prior to the 30 minute scheduled arrival time.
2. Should you or your group have CD's and wish to sell them, a booth will be set up for a representative from your group to do so, following your performance.
3. Limited time on stage including performance is up to twenty (20) minutes as well as set up and take down of equipment of your allotted time. Stage Manager will be available to assist in this to make the transition on and off stage as smooth as possible.
4. Notify Coordinator of Performing Arts/Stage Manager upon arrival of any changes/or anticipated difficulties.
5. LIFS cannot accept any cancellations seven (7) prior to the event.
